## CILC MEDICAL EXAMINER AND LABORATORY REIMBURSEMENT PROCEDURE

In our continuous effort to make it easier to do business we have sent new guidelines to all our medical examiners and laboratories. We are requesting that brokers follow the instructions below.

When submitting business all brokers are required to use our approved medical examiners and laboratories. Approved doctors and laboratories are listed by country in our website.

If you want to add a medical examiner or laboratories to our directory, please contact the Miami office. All medical examiners and laboratories are required to fill out a questionnaire in order to be part of our international directory.

All approved medical examiners and laboratories have agreed that medical services, exams, laboratory tests, and courier fees will be paid directly to them by CNA International Life in accordance with our Schedule of Fees. Neither the broker nor the patient (proposed insured) has to pay any type of fee or deductible for these services.

If for any reason a broker or patient pays for any service, CNA International Life reserves the right not to reimburse for the service.

All medical examiners and laboratories are required to send their medical receipts directly to CNA International Life. In order to ensure timely processing of all medical reimbursements the receipts should be clearly completed with the name of the patient, the type of exams performed on the client, the original doctor's signature (not a stamp), and the date in which they were performed.

The invoices must be originals and in U.S. \$. **No copies of invoices or faxes will be accepted.** All receipts should be invoiced and will be paid by CNA International Life according to our Schedule of Fees.

In all other countries, lab tests will be processed in the United States using approved Osborn Laboratory kits. Osborn kits should be ordered from CNA International Life.
